VOTING

All financial chapters are entitled to seat delegates at the Conference. Determination of the number of voting delegates are made according to chapter size as of **February 4, 2025** (based on ZMS)

Number Of Members	Allotted Delegates
1 to 4	1
5 to 25	2
26 to 50	4
51 to 75	6
76 - 100	8
100 +	8 (plus 1 for every 25 additional)

A member can cast only one (1) vote. For example, if you are a Life Member and a State Officer, you can vote as a Life Member OR State Officer, not both.
